### Rebate Checklist

Get your rebate check faster by completing these easy steps before mailing your application form. Incomplete applications may be delayed.

- Completely fill out application (mandatory)**
- Attach all receipts (original or copies)
- Attach manufacturer's specification sheets for cooking equipment (if applicable)
- Review Terms and Conditions and sign and date application
- Confirm dealer portion is completely filled out and signed (if applicable)
- Make and retain copies of all documents and application
- Send all documents to correct address listed on application (sending your application to the billing address will delay your rebate)

### Verification

A firm and final bid or sales receipt indicating date of installation, dealer/contractor name, equipment manufacturer name and model number must accompany the rebate application. Incomplete applications may be delayed. Black Hills Energy reserves the right to verify sales receipts, cancelled checks, and installations. After verification and approval, please allow four to six weeks for delivery of the rebate check.

### Tax Information

Rebates may be subject to federal and/or state income tax reporting. Applicant is responsible for contacting a qualified tax advisor to determine tax liability. Black Hills Energy is not responsible for any tax consequences of the rebate program.

### Disclaimer

Black Hills Energy does not guarantee that installation of equipment qualifying for rebates will result in reduced energy usage or demand, or in cost savings. ### Terms And Conditions

#### General Eligibility

1. Applicant must be a current Iowa commercial or industrial customer who purchases natural gas from Black Hills Energy. Customers on transport gas service are not eligible for rebates unless they contract to pay the Energy Efficiency Cost Recovery factor on their bills. Contact Black Hills Energy to determine eligibility.
2. **Equipment purchase and installation must be completed between January 1, 2025 and December 31, 2025. All applications for rebates must be received within 45 days of dealer invoice, or January 15, 2026, whichever comes first.**
3. Where applicable, energy-efficiency ratings must comply with those listed in the Air-Conditioning, Heating, and Refrigeration Institute (AHRI) directory found at [www.ahridirectory.org](http://www.ahridirectory.org).
4. This program is subject to regulatory rules and orders, and Black Hills Energy reserves the right to change or to end any portion of this program without notice.
5. A final, itemized invoice for all materials and labor related to the installation must be attached to this rebate application. Labor for self-installed projects is not eligible for rebates.
6. All equipment must be new. No reconditioned or used equipment qualifies for rebates. Equipment replaced under warranty is not eligible for rebates.
7. Applications must be completed in full; incomplete or incorrect applications will delay processing and may be returned.
8. Funding for these rebates is limited. Applications will be processed on a first-come, first-served basis. Additional information or assistance in completing your rebate application can be obtained by calling 888-567-0799.
9. Rebates may not exceed the cost paid by the customer.
