Installing energy-efficient technology is a smart way for Commercial and Industrial customers to lower their energy bills. Energy-efficient equipment installed in new construction, replacement, or retrofit projects are eligible for rebates. Prescriptive commercial/industrial rebates are available for furnaces, cooking equipment and other heating system measures.

- ☐ Send dealer portion completely filled out and signed

### Terms and Conditions

#### General Eligibility

1. Participants must be a current Black Hills Wyoming Gas commercial/industrial gas customer.
2. **Purchase and installation must be completed between January 1, 2025 and December 31, 2025. Project completion paperwork must be received by January 15, 2026.**
3. Where applicable, energy-efficiency ratings must comply with those listed in the Air-Conditioning, Heating, and Refrigeration Institute (AHRI) directory found at [www.ahridirectory.org](http://www.ahridirectory.org).
4. This program is subject to regulatory rules and orders, and Black Hills Wyoming Gas reserves the right to change or to end any portion of this program without notice. All equipment must be new. No reconditioned or used equipment would qualify for rebates.
5. A final, itemized invoice for all materials and labor related to the installation must be attached to this rebate application. Applications must be completed in full; incomplete or incorrect applications will delay processing and may be returned. The rebate cannot exceed the amount paid for item(s).
6. Funding for these rebates is limited. Applications will be processed on a first-come, first-served basis. Additional information or assistance in completing your rebate application can be obtained by calling **888-454-3312**.
7. Rebates may not exceed the total cost paid by the customer.
